Minutes of 18th Consent Appraisal Committee Meeting of 2013-2014 held on 07.10.2014 at 2.00 pm at Conference Hall, MPC Board, Kalpataru Point, 4th Floor, Sion Circle, Sion (E), Mumbai 22.

The Consent Appraisal Committee meeting of the Board was held on. 07.10.2014. Following members of the Consent Appraisal Committee were present:

The Secretary, Home (Transport) Dept., Mantralaya, Mumbai, Member could not attend the meeting. Leave of absence was granted to him.

Chairman of the committee welcomed the members of the committee and allowed proceeding of the meeting to start. The minutes of 17th CAC meeting of 2013-14 held on 30.09.2014 circulated on 08.10.2014 were confirmed.

The meeting thereafter deliberated on the agenda items (Book-let no 42.) placed before the committee and following decisions were taken.

After the verification report of the compliance as on 30.09.2014, the progress was updated and presented to CAC and it was decided as follows:

1. It was decided to grant renewal of consent for a period upto 31.07.2015 to those industries falling in category R-1 (Totally complied industries = 45 nos) as on 30.09.2014
2. It was decided to grant renewal of consent for a period upto 30.04.2015 to those industries falling in category R-2 (Substantially complied industries = 11 nos) as on 30.09.2014
3. It was decided to issue SCN for refusal for renewal of consent and forfeiture of BG for non-compliance in respect of upgradation of ETP and/or APCs for the industries falling under the category of R-3 (4 Nos) and R-4 (17 nos) (total = 21 cases) as on 30.09.2014. The reply from the industry regarding the SCN should reach the office within 7 working days. If the reply submitted is not satisfactory or reply is not received within seven working days, respective BGs shall be forfeited and directions shall be issued with BG of Rs 15 lakhs for upgradation of ETP and Rs 15 lakhs for upgradation of APCs and with time period upto 30.06.2015. The SCN to be issued shall be in the lines of the directions dated 20.06.2014 issued to the industry and draft to be prepared by SLO The case of renewal alongwith the reply of the SCN shall placed before CAC to take further decision.
4. Those units having valid consent and falling in category –R-4 (5 nos), SCN for revocation of consent and forfeiture of BG shall be issued The reply from the industry regarding the SCN should reach the office within 7 working days. If the reply submitted is not satisfactory or reply is not received within seven working days, respective BGs shall be forfeited and directions shall be issued with BG of Rs 15 lakhs for upgradation of ETP and Rs 15 lakhs for upgradation of APCs and with time period upto 30.06.2015. The SCN to be issued shall be in the lines of the directions dated 20.06.2014 issued to the industry and draft to be prepared by SLO. The reply of the SCN shall placed before CAC to take further decision.
5. It was also decided to issue circular by JDWPC to the respective SROs immediately regarding monitoring of the sugar and sugar/cogen industries falling the category R-3 & R-4 fortnightly during the crushing season till the compliance related to upgradation of ETP and/or APCs are accomplished. If non compliance is observed, then proposal to be submitted for encashment of BG immediately to this office.
