Note:

General Points:

- 1 The consents shall be disposed after obtaining requisite consent fees as per GoM, revised fee structure dtd. 25.08.2011 and according to the industry wise new validity period. The balance fees on the part of MPCB, if any, shall be considered at the time of next renewal of consent, which shall be mentioned in the consents to be issued hereafter.
- 2 The issue of returning BGs, etc in respect of Sugar, Co-gen & distillery was discussed in detail and following decisions are taken: 1. Existing BGs shall be returned while prescribing the BG conditions in consent as per new BG regime 2. The compliance period date shall be prescribed in consent considering the implementation period granted in months while finalising the BG regime 3. For BG submission period of 15 days shall be mentioned instead of putting date.
- 3 It was decided to review the committee as ex-member Dr. Thorat is not attending the meeting. RO(HQ) & TA to suggest 3 names for membership of CC. The nominees shall be preferably retired officials from construction side viz. Town Planning, Building permission department, MMRDA, MCGM, TMC, NMMC.
- 4 All applications of STP (CC & CAC) shall be referred to Consent Committee, henceforth.
