Chairman of the committee welcomed the members of the committee and allowed proceeding of the meeting to start. The minutes of the 10th Consent Appraisal Committee (CAC) meeting of 2011 held on 19.10.2011 circulated under Board's letter No. B-6007 dated 20.10.2011 were confirmed. The follow up action report of CAC meetings held earlier on 21.09.2011 to 19.10.2011 were placed before the CAC and noted. The cases pending for issue of consent letters because of non-payment of revised fees within 15 days were discussed. It was decided to send a letter to the industry to pay the revised fees, otherwise, refusal of consent proceedings are to be initiated.

Hence, it was decided to discuss the case in the meeting as a table item.</p> <p>All the points related to environmental aspects of PIL were highlighted in the note and were discussed by the CAC. It was noted that major three points in this regard are</p> <ol style="list-style-type: none"> 1. Disturbance to natural drainage system 2. Availability of water to the local people in view of the extensive water use by industries. 3. Impact of High CO₂ and NO_x emissions <p>It was noted by the CAC that the points (1) and (2) are not directly dealt by MPCB and due consideration is given to these aspects by the competent authority while reviewing EC. It was also noted that as per EP(Rules), 1986, there are no emission standards for CO₂ parameter but NO_x is included as emission standard for the gas based thermal power plants. Therefore CAC felt that regular monitoring of NO_x in stack and ambient air quality will be necessary.</p> <p>Hence, it was decided to grant consent to Establish subject to following conditions;</p> <ol style="list-style-type: none"> 1. Industry shall obtain Environmental Clearance as per EIA Notification, 2006. 2. Industry shall monitor NO_x in stack and ambient air quality regularly.

The consents shall be disposed after obtaining necessary consent fee difference from the industry as per GoM, Revised Consent fee structure dtd. 25.08.2011.

Thereafter, CAC discussed on NOCs generally required while scrutiny of the consent application and it was decided to re-discuss the same in next meeting along with statutory requirement of other Govt. departments.

The meeting ended with vote of thanks to the Chair.
