The consents shall be disposed after obtaining requisite consent fees as per GoM, revised fee structure dtd. 25.08.2011 and according to the industry wise new validity period. The balance fees on the part of MPCB, if any, shall be considered at the time of next renewal of consent, which shall be mentioned in the consents to be issued hereafter.

The meeting ended with vote of thanks to the Chair.

General Points:

<p><u>Action Point-I</u></p>	<p>1. It was observed that in some cases distance certificate obtained from Executive Engineer, Irrigation Dept. is not as per RRZ policy, 2009. Hence, <u>AST is directed to prepare a format for distance certificate from Executive Engineer of Irrigation dept. in both English & Marathi language, which shall be displayed on MPCB's website. Also communicate to Irrigation Department that as per Board's Policy consents are to be issued in 120 days but due to the requirement of above said distance certificate many cases are pending, hence Dept. shall instruct their Executive Engineer to issue the certificate at the earliest in the prescribed format only.</u></p> <p>2. During the meeting the disposal mode & standard to be prescribed for the Sewage were discussed and it was decided that henceforth, the standard for discharge of sewage on land shall be prescribed as 100 mg/lit & that for discharge in nalla/ water stream shall be prescribed as 30 mg/lit.</p>
