CORRIGENDUM

Sub. : Delegation of Powers to Head of the Departments for returning Bank Guarantees

Ref. :- Circular issued by the member Secretary of the Board
No. Bo/P&L Div-I/B- 3375 dtd. 29.5.2008

In continuation of the circular issued by the undersigned vide No. BO/P&L Div-I/B- 3375 dtd. 29.5.2008, the following corrigendum / clarification is issued.

The Regional Officers at the field have been given powers in respect of extension of Bank Guarantees for a period upto 3 months and further monitoring the compliance of the directions issued under section 33A of the Water (P & CP) Act, 1974 and under section 31A of the Air (P & CP) Act, 1981 vide Circular No. BO/R.O. (P&P)/TB/B- 1911 dtd. 24.3.2008. Further, powers are delegated to the Head of the Departments at Head Quarter in respect of the extension of the bank guarantees beyond 3 months and monitoring thereof for a period upto six months vide Circular No. BO/P&L Div-I/B-3375 dtd. 29.5.2008.

However, taking into consideration clarification asked by various Regional Offices as to whether the powers of monitoring includes returning of the bank guarantees also on the basis of operation of ETP / Pollution Control Devices satisfactorily in compliance of consent conditions / directions issued by the Board continuously for six months, has also been delegated to the H.O.D's at HQ or not?

It is hereby clarified that in case of operation of ETP/ Pollution Control Devices satisfactorily continuously for a period upto six months, the H.O.D.'s at HQ have been delegated with the powers of not only extending the Bank Guarantees and monitoring the compliance but also in respect of returning of Bank Guarantees on case to case basis. "
