Maharashtra Pollution Control Board has prepared a summery statement of all local bodies indicating class, populations, Quantum of MSW generations, status of Authorization and Form -II submission by the local bodies. Region wise abstract along with summery statement is enclosed herewith Annexure I-A. Out of 250 ULBs, MPC Board have issued renewal of Authorization to 114 ULBs and Applications of 03 ULBs have been refused by the Board and 53 applications are under process at various Regional Offices due to want of information, 80 no. of ULBs are not applied for renewal of Authorization. The % in terms of total waste generation in the corporation are is 80.48%, A class council is 6.13%, B class council is 6.34% and C class municipal council is 7.05% respectively statement enclosed- Annexure I -B. Looking to the progress made so far, and the legal time frame worked for implementation of MSW (M&H) Rules, for setting up facility as well as improvement in existing landfill has already got expired on 31/12/2003 and identification of landfill sites for future use and making sites(s) ready for operation has expired on 31/12/2002.

A summery statement on process made by Authorities in respect of implementation of schedule –II [Rule 6 (1) & (3), 7 (1)]

Maharashtra is one of the urbanized states in the country. The state is having total 250 Nos. of ULB's. Out of 250 ULBs in the State of Maharashtra, most of the local bodies have submitted their proposals for solid waste treatment and disposals by the mode of composting. The detail break up of proposal submitted by Councils & Corporations along with existing status regarding treatment and disposal is enclosed herewith in separate Annexure 1-D.

The Bio-medical waste and industrial hazardous waste generated in the area of local bodies are not mixed with MSW and such waste are disposed off separately in accordance with provisions made under BMW(Management & Handling) Rules, 1998 and Hazardous waste (Management & Handling) Rules, 1989 . For the disposal of Hazardous waste , common Hazardous waste treatment & disposal facility have been developed in the State at two locations One at TTC area operated by Trans Thane Creek Association and another at Taloja operated by Mumbai Waste Management Ltd.,. MIDC has proposed to provide CHWTSDF at Four new locations in Maharashtra at Aurangabad, Nagpur, Pune and Mahad. Similarly for the disposal of the Bio-medical waste, Common Bio-medical waste treatment facilities have been provided at 27 No. by private operator agencies in the Maharashtra State. (List enclosed Annex- II A)

1. Collection of Municipal Solid Waste:

Generally in all Municipal area littering of MSW have been prohibited. The local bodies at several places have organized collection of MSW by house to house collection, by using Ghanta gaddies, collection bins. The waste from slaughter houses, meat & fish markets, fruit & vegetable market, which are biodegradable in nature, are disposed by composting or vermi-composting.

2. Segregation of Municipal Solid Waste:

The segregation of MSW generally carried out by the mode of source segregation or in the transportation vehicle itself by the workers or in some cases, at waste disposal processing facility by ragpickars. The recyclable waste finds its route for recovery/recycling. The inert material, construction debris are being disposed by land filling/leveling.

3. Storage of Municipal Solid Waste:

The storage facility provided by ULBs in terms of RCC Bins and collected bins which are green colour coated, storage of recyclable waste of in white bins and other bins having in black colour. Manual handling of waste shall be prohibited.

4. Transportation of Municipal Solid Wastes:

Transportation of waste carried by vehicles. Transport of waste should not be visible and it is done by Ghantagadi, trucks, etc. Vehicle design should be as per handling of waste, prior to final disposal. It shall be facility of closed system of the vehicles for preventing environment. The storage facilities set up by municipal authorities shall be daily attended for clearing of waste.

5. Processing of Municipal Solid Wastes:

Municipal authorities to make technologies so as to minimizing burden on landfill. Technology for processing of waste should be done by as per usable, non-usable or recycle. The biodegradable waste should be processing of composting, vermin composting, anaerobic digestion, etc.

6. Disposal of Municipal Solid Wastes:

Land filling shall be done as per processing and non-processing. Land filling having restriction to non-biodegradable, inert waste and other waste which is not suitable for recycling. Landfill of mixed waste should be avoiding.

Summery statement or progress made by Municipal Authorities in respect of implementation of schedule-III [Rules 6(1) & (3), 7(2)]

The main constraint for the effective implementation of MSW Rules & setting up of waste processing facility for local bodies is non-availability of suitable land. Considering the constraint, the Urban Development Deptt, Govt has passed order regarding formation of District level committee in every District under the Chairmanship of District Collector. The main object of district level committee is to identify & select of landfill and waste processing sites. The Committee comprises of 10 members of various concerned department. The District level committee while identifying the suitable location for landfill and waste processing site, a care is taken that the site should be away from habitation clusters, forest, water bodies, monuments, wet lands and places of important cultural, historical and religious aspect including CRZ areas. MPCB a letter no. WP/B-4746 dt. 05.08.2003 has indicated distance criteria for selecting such sites. Board has issued letter to all concerned Regional Officer's to follow up this criteria while selecting/recommending the sites. Copy of order of site selection criteria is enclosed in annexure III-A.

Almost local bodies have provided internal roads for free movement and vehicles as well as Primary services such as drinking water, lighting at site, local bodies has planted in an around site to avoid soil erosion.

In the Maharashtra State, District level committee has so far finalized 241 Nos. MSW landfill/ waste processing sites. Remaining 09 No. of sites are under purview of District level committee for further necessary action. The major difficulties in identifications of there site are coastal regulation zone nearness to water bodies, availability of sufficient land fulfilling distance criteria opposition of local people.

Modified Check list prepared as per discussion in the meeting held on 04/06/2003 Checklist (1 to 6)

- 1. Location Plan, Site Plan, Distance from habitation, river, water bodies.
- 2. Permission/views express by the District Collector about proposed site from Town planning Authority, GSDA, Airport Authority (In case applicable).
- 3. Distance from water bodies/Forest land/national Park/Wet land/Historical places/ Habitation/Monuments etc.
- 4. Quantum of Generation of organic and inorganic MSW.
- 5. Technology details/Project details:
 - I. Environment related information as required under the rules.
 - II. Proposed Methodology of waste processing.
- 6. S.R.O./R.O. to give NOC/Site Clearance letter to Municipal Council/Corporation for setting up MSW facilities based on the decision taken by Committee appointed by District Collector for the District.

Site Selection Criteria (7 to 9)

- 7. No Development Zone distance to be kept 500 mtrs. from the boundary of the landfill site.
- 8. Capacity of site should be preferably 20-25 years.
- 9. The distance from human habitation of the site should be about 500 mtrs.

Site Selection Criteria for landfill and processing site for MSW (10 to 16)

10. The distance from river (HFL) will be as per RRZ policy i. e. is under.

- I. A-I Above 3.0 kms.
- II. A-II Above 1.0 Kms.
- III. A-III Above 0.5 Kms.

(Detail about RRZ is enclosed.)

- 11. Distance from other Water bodies (other than notified rivers) beyond 500 mtrs. avoiding up stream catchments areas of the water bodies, location should preferably at the down stream of the water body.
- 12. The distanced from National monuments and historic places etc. as mentioned in the rules, duly certified by Archeological Department should be beyond 500 mtrs.
- 13. A buffer zone- it should be 500 mtrs from the periphery of new landfill site.
- 14. The distanced from National and state highway should be more than 200 mtrs.
- 15. In respect of CRZ, RRZ rules will be followed strictly.
- 16. Old queries and low lying areas within a city may be earmarked for filling only with construction waste, debris, road dust, sift from open drains and similar non-toxic inert material only.



A SUMMARY STATEMENT ON PROGRESS MADE BY MUNICIPAL AUTHORITIES IN RESPECT OF IMPLEMENTATION OF SCHEDULE-IV [RULES 6(1) & 3, 7 (2)]

Out of 250 ULBs in the State of Maharashtra, most of the local bodies are treating their solid waste by composting to part of waste & rest goes for composting. Nashik M. Corp., Thane M. Corp, Nanded-Waghala M. Corp, Navi Mumbai M. Corp, Nagpur M. Corp, Sangli M. Corp, Kolhapur M. Corp, Pune M. Corp., Pimpri-Chinchwad M. Corp, Kalyan M. Corp, Bhokardan M. Council, have submitted to treatment of Municipal Solid Waste to be produced in near future. The detail along existing status regarding treatment and disposal is already shows in earlier Annexure **I-D**

MPC Board has carried out Ambient Air Quality Monitoring in the vicinity of waste processing facility and ground water monitoring at few facilities. So far no local bodies have installed incineration facility, but the proposal for waste to energy is under consideration at 3 ULB's.

Initiative taken/proposed by the MPC Board:

- The Board in consultation with AIILSG have prepared check list for identification of processing sites to facilitate the implementation of Rules.
- To speed up the process of grant of Authorization, MPC Board has delegated the power to respective RO's for grant of Authorization in respect of 'B' & 'C' class ULBs.
- For effective implementation and compliance of these Rules, Board has sought letter to Principal Secretary Urban Development Department, Mumbai requesting to personally look into the matter for compliance.
- The Board has extended financial assistance to five local bodies for setting up model/demo MSW projects
 - viz. 1. Murud-Janjira Municipal Council
 - 2. Baramati Municipal Council
 - 3. Navapur Municipal Council
 - 4. Ambad Municipal Council
 - 5. Sonpeth Municipal Council

Now the Sonpeth Municipal Council, Ambad Municipal Council, Navapur Municipal Council are working satisfactory. Murud-Janjira Municipal Council is in advance stage. Baramati Municipal Council has obtained technical sanction and going to inviting tender.

- The Board has give showcause notice to Thane Municipal Corporation, Navi Mumbai Municipal Corporation for non-compliance failure to provide treatment & disposal facility. MPCB has conducted with ULBs to create awareness of MSW management. Also took part, supported financially to arrange workshop/seminars in this field & made presentation.
- Continuous and strict follow up taken by MPCB has resulted in establishment of such large no. of Municipal Solid Waste facilities may be to part of the Municipal Solid waste. This will be further extended to their complete municipal waste generated.
- Aurangabad Municipal Corporation has appointed MPC Board to act as Project Management Consultant for helping and guiding them to selecting the technology & the facility producer for management of Municipal Solid waste in their Corporation area.
- Board has given financial assistance to the religious places for installation of MSW plant scientifically treatment and facility, i.e. Shegaon, Shani-Shingnapur, Dehu, Alandi, Shirdi, Pandharpur, etc.

• Board has given notice to Kolhapur Municipal Corporation and his facility operator m/s. Zoom Bio-Fertilizer Pvt. Ltd. to ensure proper management of MSW at Kolhapur as Board has record complaint against them for improper operation & maintenance.

Constraints/difficulties in Implementation:

- Non availability of suitable land for handing over to concerned local bodies that are not having their own land.
- The local bodies in coastal area are facing the difficulties in identification of suitable land due to CRZ notifications.
- The locational policy of State Government in respect of notified Rivers (RRZ Policy) doesn't allow for sitting of such type of activity
- Selection of proper waste processing technology with respect to waste generation including waste to energy plants.
- Non availability of sufficient funds with local bodies.
- Lack of public awareness/participation.
- Lack of manpower with MPC Board for proper and effective implementation & monitoring of MSW (M&H) Rules, 2000.

Suggestions:

- Speedy identification and handing over landfill and waste processing sites by State Government to concerned local bodies particularly in the coastal region.
- Low cost standard models shall be made available for 'B' & 'C' class Councils.
- Provision of adequate funds to ULB & MPCB for effective implementation of MSW Rules, 2000.
- Requisition of additional manpower to MPCB for environmental monitoring in respect of AAQM & ground water monitoring in the vicinity of waste processing sites.
- The schedule-I prescribed in MSW Rules be amended for new time schedule, since the most of the local bodies have failed to adhere the implementation schedule due to above mentioned difficulties.
